Responsible investments (RI) and Environmental, Social and Governance (ESG) factors have been key topics for the financial society of developed countries for the last five years, while most of emerging markets remain behind this trend. CIS countries have only recently joined this global financial initiative: the first green bonds were issued in 2018, as well as several companies and financial institutions from the CIS have recently gone through ESG/sustainable finance certification.
